Before boarding it is necessary for us to have proof, in the form of a receipt from your vet, that your dog is up to date on all of the above vaccinations.

We require that all dogs admitted to the facility must be spayed or neutered as well as up to date on all vaccinations, including **DHLPP** (distemper, Leptospirosis), **RABIES**, and **BORDATELLA** upon check in. Please provide proof (a receipt from your vet) that your pet meets these requirements. We do not accept dogs whose owners administer their own vaccinations. Please make any arrangements necessary to ensure that we receive these records.

Please keep in mind that your dog may receive minor scratches during play with other dogs (think of this as children at daycare). However, if your dog receives any wounds that require medical attention, we will make arrangements with you if you are available or transport your pet to either your vet, our on call veterinarian Dr. Handerhan or the closest animal hospital to received prompt medical attention. Any medical cost that is incurred as a result of treatment will be repaid to Always There Pet Care L.L.C. upon arrival for pick up.

I hereby authorize Always There Pet Care L.L.C. to transport my pet if medical attention is needed. I also give permission to administer vaccines if needed. Animals that are infested with fleas or unusually soiled will be bathed at the owner's expense. I agree to reimburse Always There Pet Care L.L.C. for the full amount of any medical cost upon arrival for pick up.

Due to the amount of physical activity entailed at Day Care, upon return your dog may experience a loss of appetite and/or exhaustion. Also, due to the fact that dogs have free roam of the facility, please be aware that we are not responsible for any dropped off items; such as bowls, blankets, toys, etc.. We have come to find that some dogs feel that everything belongs to them.

I understand that I am responsible for paying Always There Pet Care L.L.C. when using their boarding services. The fee for a 24-hour period is \$50.00 and any time exceeding these 24-hour durations of time will be pro-rated as a day care fee. If I have two dogs boarding, I understand that the fee for the first dog will be \$50.00 per 24 hours and the cost for the second dog will be \$35.00 per 24 hours.

Payment is due in full before pick up of your animal.
